PROFILE: Having graduated from the School of Law and Government, DCU, with a PhD in March 2005, I am currently working as a lecturer in International Political Economy, Comparative Politics and Irish Politics in the Technological University Dublin.

I am able to work on my own initiative or as part of a team, having collaborated extensively with colleagues in the TU Dublin, other Irish universities and many institutions abroad. I have a proven track record in research, publication, and teaching, and am dedicated to maintaining high standards in all three areas.

I have won three IRCHSS research fellowships (total value €175,000), having been a graduate, doctoral and postdoctoral IRCHSS research fellow. I have been part of an international collaborative research project, funded by the Canadian Social Sciences and Humanities Research Council (SSHRC) under a partnership development grant, valued at \$350,000.

I have conducted two postdoctoral research projects, and hold membership in the Political Studies Association of Ireland, the Political Studies Association (UK), and the American Political Science Association and the Midwest Political Studies Association. I was chair of the Comparative Policy

Section of the MPSA from 2016-2018. I am also a co-founder and co-director of the Business, Society and Sustainability Research Centre in the College of Business, TU Dublin.

I have consulted with and advised the Irish, Czech, UK, EU and Scottish, governments on issues surrounding lobbying, its regulation and matters to do with transparency, accountability and ethics in government. With my research collaborators, I have appeared before various committee of these governments. From 2011 to 2015 I worked closely with civil servants in the Department of Public Expenditure and Reform on the development of the government's Regulation of Lobbying Act (2015).

I am lead editor of the volume *Irish Business and Society* (2010) which examined the politics and economics of contemporary Ireland. I am a founding director of the DIT Business, Society and Sustainability Research Centre in the College of Business. I am a co-author of *Regulation Lobbying: A Global Comparison* (1st and 2nd editions) and I am also lead editor of the volumes *Policy Paradigm in Theory and Practice* and *Approaches to Qualitative Research: A Guide for Dissertation Students*, and *Policy Analysis in Ireland*, published on 5 March 2021.

I research public policy and its impact upon business and society (theory and practice) and also focus on lobbying policy development and implementation.

I teach courses in Irish Business and Society, International Political Economy and Irish politics in the TU Dublin. I previously taught American Politics in the School of Law and Government in DCU from 2001 to 2008.

We have published a range of

papers and book chapters from this research project, along with producing 10 separate sets of evidence submissions to various government.

Thirdly, managing and directing research on understating policy change at times of economic crisis in various countries across the world (2005-2021). This research has resulted in the publication of 3 books, 3 book chapters, and 16 academic peer reviewed journal articles, along with numerous conference papers presented in Europe, and North America. In that time I have also chaired panels on this topic at all of the major political science conferences from APSA, and the MPSA to the ICPP. Between 2016 and 2018 I was also chair of the Comparative Policy Section of the MPSA in the US.
